## ***Imiphi imisebenzi esemqoka yoMyango Wezimakethe Zezimali ongaphansi kweBhodi Yosizo Lwezezimali ("FSB")***

Ngokuya ngokoMthetho Wezimakethe Zezimali, uMnyango weziMakethe Zezimali ongaphansi kwe-FSB iwona obhekelela ukuqondiswa kwabagunyazwe yi-JSE, inhlango ye-zibambiso zamasheya, (i-Strate Limited) nama-clearing house, okuyi-Strate Limited kanye ne-Safex Clearing Company (Pty) Ltd (SAFCOM). I-exchange ne-central securities depository izinqalasisinda ezisebenza ngokuzimela njengoba ngaphansi koMthetho Wezimakethe Zezimali zinesibopho sokuqapha amalungu abo agunyaziwe ukuthi ahambisane nemithetho ye-FMA. I-FMA ibuye ivumele i-ejenti ebhekelela ukuxazululwa kwama-akhawunti okuhweba ukuba asebenze ngokuzimela ekubhekeleleni ukunakekelwa kwama-akhawunti amalungu. I-Strate Limited sinakekela izimali nezibopho ngenkathi i-SAFCOM inakekela ama-derivative instruments.

## ***Umuntu angonga kanjani kumasheya abhaliswe kwi-securities exchange?***

Ingosi ye-JSE inohlu lwenzinkampani abatshali zimali abangaya kuzo ukuze zibasize ngokukhetha amasheya abangonga kuwona. Ilungu lingaba njengemenenja yokutshalwa kwezimali komtshali zimali, angathengela futhi athengisele umtshali zimali amasheya akhe kwi-discretionary basis, noma umtshali zimali angaluleka ibhroka yakhe ukuthi ahlangelele emasheyeni eliwakhethile. Abatshali bezimali kumele bazinike isikhathi sokubheka amasheya enzakahle ngaphambi kokuthatha isinqumo sokutshala imali; kumelwe babheke umlando wezezimali waleyonkampani, ukuphathwa kwayo, nokuthi ingabe ibhalisiwe yini neJSE, njll.

Izinkampani ezingabhalisiwe okwamanje azilawulwa ngendlela efanayo nalezo ezibhalisiwe kanti futhi abatshali zimali bezinkampani ezingabhalisiwe abavikelekile ngokomthetho.



## ***Umtshali zimali uzokwazi kanjani ukuthi umuntu/inkampani asebenzelana nayo inayo imvumo yokuhlinzeka ngalolosizo?***

Maqondana nezinkampani ze-JSE, abatshali zimali bangashayela i-JSE ukuze bathole ukuthi ingabe ngempela leyonkampani iyilungu le-JSE kanti futhi bangaphinde bevakashele nengosi ye-JSE. Maqondana nabahlinzeki bosizo lwezezimali, abatshali zimali bengaxhumana noMnyango we-FAIS engaphansi kwe-FSB ukuze bahlale ukuthi ingabe loyo mhlinzeki ubhalisile ne-FSB noma cha.

## ***Kusho ukuthini ukuba i-SRO kanti buyini ubudlelwano phakathi kwe-FSB ne-SRO, ingabe uhwebo, izibambiso kwi-central depository noma i-clearing house ezimele?***

I-FMA ihlinzeka imakethe ngezingqalasizinda ezifana ne-exchange, kwi-central securities depository kanye ne-clearing house ezimele ukuze zigunyazwe iSRO. I-FMA iveza ngokucacile imithwalo yezimfanelo ze-SRO. I-SRO inesibopho ngaphansi kwe-FMA sokuqondisisa amalungu ayo futhi nokuqinisekisa amalungu ayo ukuthi ahambisana nemithetho ye-FMA. I-exchange, ne-central securities depository noma i-clearing house ezimele zifeza indima ye-SRO ngaphambi kokuba zigunyazwe yi-FSB. I-SRO inesibopho sokuqunyaza amalungu ayo.

### ***Ukufaka isikhalazo***

***Imiphi imigudu elandelwayo ukuze umtshali zimali afake isikhalazo sakhe maqondana nohwebo, i-central securities depository kanye ne-clearing house ezimele, noma amalungu ayo, nanoma abaphathi nabasebenzi bamalungu?***

### ***Siyini isikhalazo sika mtshalizimlai?***

Isikhalo somtshali-zimali sichazwa njenganoma yisiphi isikhalo esifakwa maqondana nokuhlinzekwa kwemisebenzi elawulwayo (leyo misebenzi okungukulawulwa kohwebo, i-central securities depository noma i-clearing house ezimele) okuyilapho umtshali zimali esho khona ukuthi uyewahlupheka, noma angahle abhekane nobandlululo lwezezimali ngenxa yelungu, isikhulu noma umsebenzi welungu:

- Ukwephula noma ukwehluleka ukuhambisana nanoma yimiphi imiyalelo enikezwa ngumtshali zimali , noma isivumelwano noma igunya analo nelungu;
- Ukwephula noma ukwehluleka ukuhambisana nemithetho neziqindiso ze-FMA ne-SRO;
- Ukwenza ngokungathembeki, ukunganaki noma ukwenza budedengu; noma
- Ukuphatha umtshali zimali ngokungafanele.

Ngale kwalezi zikhalazo ezibalulwe ngenhla amalungu noma abaphathathi noma abasebenzi, naye umtshali zimali angaba nesikhalazo esibhekene nayo:

- I-SRO ngokungenzi imithwalo yayo ngokufanele, ukwenza ngendlela engeke ifeze izinhloso ze-FMA njengoba libalwe kwisigaba sesi-2 se-FMA noma ukwehluleka ukuhlinzeka ngendlela ye-FMA.

**Abatshali zimali bayalwa ukuba babheke imithetho nezimfaneko zokufaka izikhalo, ikhophi iyatholakala engosini ye-exchange.**

### ISINYATHELO 1: Faka isikhalazo nelungu.

Isikhalo sokutshalwa kwezimali kumelwe siqale sifakwe bese kuxoxiswana nelungu elifanele ngokwenqubo yangaphakathi yokuphathwa kwezikhalazo. Ukuphathw kwezikhalo zamalungu kwangaphakathi, kubhekelela ukuthola izikhalo

zabatshali zimali, uphenyo olufanele lwesikhalo, impendulo efanele ngesinqumo esimayelana nesikhalazo somtshali zimali, ukwaziswa ngesinqumo kanye nokuqopha lesi sikhalazo.

### ISINYATHELO 2: Faka isikhalo ne-SRO.

Uma umtshali zimali enganelisekile ngesisombululo esikhishwe yilungu, noma isikhalo sihlale singasombululwanga, kumelwe abhale isikhalo sakhe esinemininingwane yonke yodaba lwakhe asidlulisele kwi-SRO. I-SRO izozama ukuzisa nesisombululo ngesikhalo esiphakathi kwelungu nomtshali zimali.

### ISINYATHELO 3: Phikisana nesinqumo ngokudlulisela kuMlamuli oqokwe yi-exchange

Uma i-SRO ingakwazi ukuba nesombululo, ingahle ivume lokho kuphikisa bese iphatha lesosikhalo ngokwesiphakamiso esenziwe ngokuya ngemithetho yeziphakamiso, uma umtshali zimali ekhetha ukulandela inqubo yokuxazulula izingxabano futhi uma egcina uhlelo njengoba luchazwe kwimithetho ye-exchange. Ingxabano izobese idluliselwa kuMlamuli oqokwe ngaphansi kohlelo lwe-exchange lokuxazulula izinkinga zamaklayenti, eqashelwe yi-Finacial Service Ombud Schemes Act ka -2004 ukuze sibhekiswe kahle isinqumo esithathwe nguMlamuli.



Uma i-SRO ingenalo uhlelo lokuxazulula izinkinga njengakwi-central securities depository, ofake isikhalo kumele asilethe kuMlamuleli Wosizo Lwezezimali leso sikhalo. Isikhalo kufanele sihlobane nobandlululo lwezezimali noma ukulimala ngenxa yokwephula noma ukwehluleka ukuhambisana nekhomishana ye-FMA.



Lo ofaka isikhalo kuzofanele aveze ubufakazi kuMlamuleli bokuthi uyewazama ukulungisa inkinga. Lokhu kungenziwa ngokukhipha ikhophi yempendulo yokugcina ye-SRO noma ye-FSB, kanye nezizathu zokuphikisana nempendulo. Isikhalazo kumelwe sithunyelwe sibhaliwe kuMlamuleli kuhlangukanye namaphepha asekelayo.

**Izindlela zokuphatha izikhalo zabatshali zimali ngokumelene ne-SRO noma iziphathimandla kanye nabasebenzi be-SRO.**

### **ISINYATHELO 1: Faka isikhalo ne-SRO**

Isikhalazo sabatshali zimali sokukhononda nge-SRO kumelwe sifakwe ngokubhalwa bese kuxoxiswa ne-SRO efanele. Imininingwane egcwele kumelwe inikezelwe kwi-SRO.

### **ISINYATHELO 2: Faka isikhalazo kwi-FSB**

Uma i-SRO ingakwazi ukuxazulula isikhalo, umtshali zimali kumelwe adlulisele isikhalo eMnyangweni Wezimakethe Zezimali ongaphansi kwe-FSB. Kuzoxoxiswa ne-SRO ethintekayo ukuze kuqinisekise ukuthi leyo-SRO yenze okufanele ekuxazululeni leso sikhalo ukuze kwaneliseke wonke umuntu othintekayo.

### ***Kumelwe zifakwe kanjani izikhalo zabatshali zimali?***

Izikhalo zabatshali zimali kumelwe zibhalwe phansi. Isizathu salokhu, ukuthi kufanele kutholakale isizinda nezizathu zesikhalo zomtshali zimali ukuze i-FSB ikwazi ukuxoxisana ne-SRO efanele.
